Please note: New Hampshire law defines a farmers' market as "an event or series of events at which 2 or more vendors of agricultural commodities gather for purposes of offering for sale such commodities to the public. Commodities offered for sale must include, but are not limited to, products of agriculture as defined in RSA 21:34-a. "Farmers' Market" shall not include any event held upon any premises owned, leased or otherwise controlled by any individual vendor selling therein (RSA 175:1). If the market does not meet this criteria it may be ineligible for some state programs. Markets must register as a first step to allow NH wine and beer vendors to sell.
